This is a temporary, full-time seasonal position from 04/01/2018 to 12/15/2018.

Duties: Install: irrigation systems, drainage systems. Maintain irrigation systems, including winterizing the systems and starting them up in spring. Use irrigation methods to adjust the amount of water consumption and to prevent waste. Spread straw over seeded soil to hold soil in place. Digging: use hand tools: shovels. Irrigate lawns, trees, or plants. & other related Groundskeeper: Irrigation Worker activities as per SOC/OES 37-3011 (onetonline.org). Requirements: Must be 18 due to insurance. Must show proof of legal authority to work in the U.S. Drug/Alcohol/Tobacco free work zone.
