This is a temporary, full-time seasonal position from 2/15/2017 to 12/15/2017. 1 month irrigation installation experience preferred. Duties: Install: irrigation systems, drainage systems. Maintain irrigation systems, including winterizing the systems and starting them up in spring. Use irrigation methods to adjust the amount of water consumption and to prevent waste. Spread straw over seeded soil to hold soil in place. Digging: use hand tools: shovels. Irrigate lawns, trees, or plants & other related Irrigation & Groundskeeping Worker activities as per SOC/OES 37-3011 (onetonline.org). Requirements: Performing physical activities: such as lift, balance, walk, stoop, handle, position, move, manipulate materials use static strength to exert maximum muscle force to lift, push, pull, or carry objects up to 50lbs. Must show proof of legal authority to work in U.S. Must be 18 years of age due to insurance. Drug/Alcohol/Tobacco free work zone. No min. edu. reqmt. OJT. All applicants must be able, willing, qualified to perform work described and must be available for the entire period specified and work throughout all areas of intended employment. Terms & Conditions of Employment: \$13.95/hr up to possible \$18.50/hr OT \$20.93/hr up to possible \$27.75/hr, DOE: wage may vary, at least 35hrs/wk, M-F, 7:30 am to 5:30 pm. The wage(s) offered equal(s) or exceed(s) the highest of the prevailing wage or the Federal, State, or local minimum wage. Possible weekend/holiday work. Variable weather conditions apply; hrs may fluctuate (+/-), possible downtime/OT. OT not required. This employer will also comply with all applicable federal, state and local laws pertaining to overtime hours.
